## MINUTES CONCORD TOWNSHIP BOARD OF TRUSTEES REGULAR SESSION

August 10, 2021

The Concord Township Board of Trustees met in Regular Session at 10:00 a.m. on Tuesday, August 10, 2021. Trustee Don Pence called the meeting to order and led the Pledge of Allegiance. Trustee Neil Rhoades was present as was Fiscal Officer Bill Whidden and Road Superintendent Brandt Miller.

Minutes: Approval of the minutes from July 13,2021 was deferred until the September 7,2021 meeting.

<u>Guests:</u> Kevin Harlan, President of the Upper Valley Medical Center reported the roof replacement project of the hospital continues and is expected to be completed by year end. He also reported UVMC currently has 8 Covid patients and the hospital recently changed its policy to require all employees, visitors, contractors and venders t be masked. Certain religious and medical exemptions would apply on a case by case basis.

Deputy Sheriff Randy Slusher attended and informed the Trustees the Sheriff's Office has a "decoy" vehicle available and can be placed in the township to help prevent speeding.

- Reported the Diana Drive and Pine Street storm water ditch project has been completed.
- Reported that the properties located at 1220 Maple Street and 1630 S. County Rd. 25A have been mowed. The property at 1670 S. County Rd 25A has not been mowed the home itself is in very poor condition.
- Brush pick-up for the month totaled 15 loads.
- Catch basin clean out has been completed.
- The crew has begun preparations for dura-patching.
- The crew has also begun leaf equipment preparation for the upcoming leaf season. Brandt discussed the need to replace the hose and estimated the cost at up to \$1,200.

- A Mr. Whidden presented Resolution 2021-07, to amend the Personnel Manual to reflect the Trustee's decision at the July 13, 2021 meeting to add "Juneteeth" as an officially recognized Holiday for all eligible employees. Mr. Rhoades made a motion to approve the resolution and was seconded by Mr. Pence.
- B. Mr. Rhoades moved to amend the minutes form the May 11, 2021 meeting to reflect the cost of renting the Township Dura-Patcher to Union Township should be \$60.00 per hour rather than the \$100.00 per hour reflected in the minutes from May 11,2011. Mr. Pence seconded the motion and it passed unanimously.
- C. Mr. Whidden presented Resolution 2021-06 to Amend the Permanent Appropriations for 2021 as a result of receipt of \$291,993.58 from the American Rescue Plan Act. The Resolution was adopted upon motion by Mr. Pence and a second my Mr. Rhoades.
- D. Discussion was help regarding eligible uses for the funds received under the American Rescue Plan Act. The Trustees agreed the Diana Dr./Pine Street Storm Water project meets the Acts definition under the "vital wastewater and stormwater infrastructure" section. Mr. Whidden was instructed to keep records of the expenses for the project and use the funds from American Rescue Plan for payment. Mr. Pence further suggested the Trustees reach out to Miami County and the City of Troy to investigate possible collaborative projects for efficient use of the funds.
